You will see point II (a. b. c.) of the attached statement is addressing your question.

The Office for Outer Space Affairs is the substantive Secretariat to the Committee on the Peaceful Uses of Outer Space and its Scientific and Technical and Legal Subcommittees.

The Committee was established by the General Assembly in 1959 as its subsidiary body, and is the main international intergovernmental forum for matters relating to the peaceful exploration and use of outer space. The Committee's membership is comprised of 83 States members (as of 2015). The Legal Subcommittee has negotiated five international treaties and five sets of principles which encompass major issues of outer space exploration and use and international space cooperation.

The Office discharges the responsibilities of the Secretary-General under the treaties and principles on outer space which include, among other things, the dissemination of information under the treaties and principles and substantial supervision and maintenance of the United Nations Register of Objects Launched into Outer Space.

The Office is not in a position to comment, evaluate, or interpret national space legislation of Member States.

Please find an official letter written by the Traditional Kanien'keha:ka (Mohawk) Council based in Kahnawake Mohawk territory.

We ask you to urgently share this letter to all key decision makers relating to the development and commercialization of the moon.

You and I have initially spoken on the phone back in February and you had given me reassurance that no mining would be happening on the Moon. We have now heard the news that the United States gave the go ahead to a private company to land on the Moon. That company is taking part of the international Google XPrize contest. They expect to land on the Moon in 2017.

We reiterate to you that we are extremely worried about these plans as they will no doubt open the door to extrat Helium 3 and other life ressources of the Moon, which will have irreparable negative impact for all Humanity.

We will be traveling to Gudalajara Mexico as we know the Space Generation Congress for the youth and the International Astronauts Congress are taking place there. We will drive 7,500km in order to be at this meeting and/or any other meetings taking place there. We will be arriving on the 22nd of September.

I write as Liaison Two Row Wampum for the Kaniienkehaka Traditional Council you have met a few years ago.

Stuart Myiow, who I copy here on this email, gave me your email for me to deliver an extremely important message and urgent call to action to save our Grand-Mother Moon from imminent colonization.

No Moon - No Magnetic Field - No Life on Earth. Altered Moon - Altered Magnetic Field - Altered Life on Earth.

The Kaniienkehaka Traditional Council have been actively involved since 2012 in protecting the Moon from colonization.

The situation as it stands today, March 21st, after Donald Trump passed the Bill S.442 this morning at Congress, is nothing less than alarming.
